Each participant in "So Ya Wanna Be A Broadway Star" will be offered the chance to sing in our annual Holiday Show on Dec 9 and 10th at Fairfield Theatre Company Rehearsal *times* are TBD but will be December 3-8th at Emmanuel Church.

Upon receipt of the fully signed Application Packet you will receive an e-mail acknowledging your application has been received. You will have two (2) days from submission of your Application Packet to pay the Application Fee. Upon receipt of the Application Fee, the Applicant will receive an e-mail confirming they are qualified to participate in the Event.

12. Would you like to be considered for our "Favorites" concert on Nov 19th. You will sing your "So Ya Wanna Be A Broadway Star?" song or perform your monologue again.

13. Would you like to be in our Holiday show Dec 9/10th ? This is a professional production with local performers and Broadway performers.

14. Would you like to be considered for the ensemble in our co-production of The Music Man with the Norwalk Symphony Production : Feb 10th Saturday 7:30. Snow Day Feb 11. Rehearsals the week of Feb 4-9th. This is a professional production with a full symphony<sup>2</sup> orchestra and Broadway performers.

## **RULES AND REGULATIONS**

1. All Applicants/Contestants (or applicable Parent or Guardian) must complete each of the following to be considered “registered” for the event:
  1. Fill out the entire application;
  2. Sign the Waiver and Release Form at the bottom of this application.
  3. Return the fully signed Application Form, digital headshot and resume to:

  4. Pay the Application Fee.
2. Once the Applicant is registered they are considered a Contestant.
3. All Contestants (or applicable Parent or Guardian) must bring this printed and signed original document to register on the first day of the event.
4. Until payment of the application fee is made Applicant is not officially entered into the event.
5. APPLICANTS MUST BE AT LEAST 8 YEARS OF AGE BY the first day of the Event (unless given special permission by the Artistic Director)
6. If Applicant is a minor, a parent or legal guardian must sign the Waiver and Release for the Applicant. The parent/guardian that signs the Waiver and Release must be the one that accompanies the minor Contestant to registration on the day of the event. If a different parent or legal guardian accompanies Contestant to registration, a new Waiver and Release must be signed or Contestant will not be permitted to participate in the event. THERE WILL BE ABSOLUTELY NO EXCEPTIONS.
7. If Contestant is a minor the Contestant’s parent or legal guardian must bring a government-issued document that identifies the Contestant.
8. If Contestant is accompanied by their legal guardian, the legal guardian must bring proof of guardianship (for example, a court order) on the day of the event.
9. Due to time constraints the Event is limited to 20 contestants. The New Paradigm Theatre will accept the first 20 applicants who submit a completed Application Form, signed Waiver and Release Form, and pay the Application Fee. If an Applicant’s materials are received after the first 20 contestants have been accepted The New Paradigm Theatre will not be able to register the Applicant for this Event. Please "Like" our Facebook page "The New Paradigm Theatre" so you can stay in the loop for the next event.
10. **There are no refunds of the Application Fee for any reason, unless the Applicant paid the Application Fee but was not accepted by New Paradigm Theater as a Contestant in the Event. If, however, *New Paradigm Theatre* cancels the event due to a cover outbreak or related, you will be given a refund.**

11. Contestants must send a digital headshot and resumes of themselves along with the application. Do not worry if they are not professional. Those materials will be distributed to each of the judges. Many of our judges keep those in their files for future shows and will refer to them during the event.
12. The judges will comment on each Contestant in the following categories 1. Singing/Acting (technique) 2. Presentation (your storytelling, clarity of emotion) 3. Your "look" (audition outfit, hair, makeup etc.) 4. Your professionalism (attitude, material preparation etc.)
13. NPT will supply a professional accompanist the day of the event. Please send a PDF of your music to [info@nptheatre.org](mailto:info@nptheatre.org) a week before the event.
14. Each Contestant's music must be in a binder, and hole punched. Music should be back to back and with cuts clearly marked. Monologues should be memorized.
15. No accapella singing or lead sheets will be accepted. All material should be memorized and in the correct key.
16. You must provide your own transportation to the event.
17. Each contestant will get only one chance to perform on the day of the event.
18. You agree that The New Paradigm Theater may cancel the Event at any time, at its sole discretion, including without limitation, as the result of a Covid-19 outbreak. In addition, by participating in the Event, you assume the risk that you or your child may contract Covid-19, and as such, you discharge and release The New Paradigm Theater from any liability therefore.

**NOTE: On Sunday, November 5th, the event will begin at 1pm. Please arrive by 12:30 am to sign in. Each Contestant will perform a short song or monologue of their selected theatre piece for the judges. Any genre of theatre song or monologue that shows you off the best (may include pop, rock, jazz, country music, or monologue from any play (please avoid profanity etc.) You must have your selection memorized. You may also do a song and a monologue back to back as long as the selections do not exceed 2 minutes.**

## **WAIVER AND RELEASE**

I, the undersigned Contestant (or parent or guardian of Contestant), agree to appear (or in event of parent or guardian, allow Contestant to appear and participate), in the event "SO YA WANNA BE A BROADWAY STAR" (hereinafter, the "Event") presented by The New Paradigm Theatre Company, Inc., (hereinafter, "NPT") and NPT advertising, marketing and public relations campaigns. I understand that my (or minor's) name and image will be recorded by various mechanical and electrical means of all descriptions, including but not limited to still photography and video (the "Released Subject Matter").

In consideration for being allowed to voluntarily participate in the above--referenced event, I (or the undersigned or parent and/or legal guardian) freely and without restraint consent to and give to the NPT and its agents or assigns or anyone authorized by NPT (collectively, the "Releasees") the unrestrained right in perpetuity to own, use, or alter the Released Subject Matter for no cost and in any manner the Releasees may see fit and for any purpose whatsoever, all of the foregoing to be without limitation of any kind. Without limiting the generality of the foregoing, I hereby authorize the Releasees and grant unto them the unrestrained rights to use the Released Subject Matter in connection with advertising, publicity, public displays and exhibitions.

I hereby waive to the fullest extent that I may lawfully do so, any causes of action in law or in equity I (or the minor Contestant) may have or may hereafter acquire against the Releasees or any of them for libel, slander, invasion of privacy, copyright or trademark violation, right of publicity, or false light arising out of or in connection with the use by the Releasees of the Released Subject Matter.

It is my intention that the above mentioned consideration represents the sole compensation that I (or the minor Contestant) am entitled to receive in connection with any and all use of the Released Subject Matter. I expressly stipulate that the Releasees may use the Released Subject Matter or not as they choose in their sole discretion without affecting the validity of this Release. This Release shall be governed by Connecticut law without regard to its conflict of laws principles.

I hereby acknowledge that any prizes awarded to me (or the minor Contestant) as a part of this event are not a guarantee and do not constitute or create a contract, express or implied, that I (or the minor Contestant) will be given or obtain a role in a so called Broadway or Off- Broadway production. I further acknowledge that any prizes awarded not constitute employment, a promise of employment contract of employment to work in any production anywhere in the world whatsoever.

### **Waiver of Liability and Indemnification:**

In consideration for being allowed to voluntarily participate in the above--referenced event, the Contestant (or Contestants parent or legal guardian) forever:

- a. waives, releases, and discharges NPT and its agencies, officers, and employees from any and all liability for the Contestant's death, disability, personal injury, property damages, property theft or claims of any nature which may hereafter accrue to the Contestant, and the Contestant's estate as a direct or indirect result of participation in the Event; and
- b. defend, indemnify, and hold harmless the NPT, its agencies, officers and employees, from and against any and all claims of any nature including all costs, expenses and attorneys' fees, which in any manner result from Contestant's actions during this Event.

Consent is given for the Contestant to receive medical treatment, which may be deemed advisable in the event of injury, accident or illness during this Event. This release, indemnification, and waiver shall be construed broadly to provide a release, indemnification, and waiver to the maximum extent permissible under applicable law.
